DESCRIPTION

This course is the competency refresher for individuals to fulfil the role of a **Track Force Protection Coordinator (TFPC) 3.3** in the Metro Trains Melbourne Rail Network (MTM).

AUDIENCE

This course is for **TFPC 3.3s** working in the MTM Metropolitan Rail Network that have held their competency for 24 months and need to maintain TFPC 3.3 competency.

This course is not suitable if you have already attained the **TFPC 3.3** competency from a [non-approved MTM training provider](#) and are unable to work on the MTM Metropolitan Rail Network.

The **TFPC 3.3 (MTM conversion)** is required if the above applies.

PROOF OF IDENTITY REQUIREMENTS
